Subject: Winter Recess Heating Turndown

In its Sustainability Vision, Emory has set a goal to reduce energy use per square foot by 50% from 2015 levels by 2025 and achieve net neutral greenhouse gas emissions by 2050. As part of the campus strategy to help reach these sustainability goals, and consistent with efforts over the past several years, we will again be reducing energy usage by turning down heat in buildings that are unoccupied for extended periods of time over Emory's winter recess.

From December 24, 2020 – January 3, 2021, we plan to program the heating systems in designated buildings to maintain a minimum temperature of 55°F which will reduce energy usage while still protecting building contents. We will assume building participation or exclusion based on each building's status last year. Please review our list of <u>excluded buildings and Frequently Asked Questions</u> for more details.

We also ask all building occupants to turn off interior lights, computers, and other office equipment before leaving for winter recess.

Winter Recess Heating Turn Down Exceptions List Turndown Period: December 24, 2020 – January 3, 2021

Exceptions (exceptions are in red):

 - OPER OFF AHUs 1 & 2, leave Lab AHUs on
- 4. Goizueta Business School
 - Leave on AHU-2 & AHU-4 for RMs 201-204 & 234
- 5. Grace Crum Rollins Building
 - Except floors L, P and 1
- 6. Health Science Research Building
 - Air handlers 3 and 4 only; Except lab areas and bridge area
- 7. Math and Science
 - Except lab areas
- 8. Oxford Road Building
 - Except Starbucks
- 9. Theology- Rita Anne Rollins Building/ Ethics:

- Except AHU-3 always on. Monitor temps third floor Art Gallery 361 stay
 between 65°F-75°F OPER AHU-2 if needed.
- 10. School of Medicine
 - Excluding A wing AHUs AB-1 and CP-3 for entire period
- 11. Woodruff Health Sciences Center Administration Building (WHSCAB)
 - Exclude from shutdown for the entire period.
- 12. 1599 Clifton Building
 - Exception AHU-3 occupied 12/26-12/27

Winter Recess Heating Turn Down Frequently Asked Questions December 2020

What is the Winter Recess Heating Turn Down?

The *Winter Recess Heating Turn Down* is an effort to reduce energy usage in buildings that are unoccupied during extended periods such as Winter Recess.

For participating buildings, the heating system is programmed to maintain a minimum temperature of 55°F. This will reduce energy use while still protecting building contents.

Why does Campus Services turn down the heat over Winter Recess?

As part of its sustainability vision to address environmental, social and economic impacts of campus operations, Emory has set goals to reduce energy use 50% per square foot from 2015 levels by 2025 and achieve net neutral greenhouse gas emissions by 2050.

What are the Winter Recess Heating Turn Down dates for 2020?

Winter Recess: December 24, 2020 – January 3, 2021

Which buildings are impacted by the Winter Recess Heating Turn Down?

If your building participated last year, we will assume your building will participate again this year. If your building was excluded last year, the same exclusions will apply this year. Please review the exclusion list for buildings or specific areas which are excluded from the heating turn down.

We assume that all buildings not on the exclusion list will participate *unless* that building has made contact with Campus Services Work Management for an exception. If your building will be unoccupied from December 19 or earlier until January 3, please contact Campus Services for an extended turndown.
